Once skies re-open, what will be done by Tailor Made Tours to insure your safety while travelling to the holyland?

✓ The Tailor Made Tours team members that will interact directly with the delegation will be subject to a COVID-19 test which will be done within 72 hours prior to arrival.

✓ The vehicle that will pick you up on arrival and be with you throughout the tour will be disinfected, including its trunk, all in accordance with the regulations of the Israeli Ministry of Health.

✓ All team members interacting with the delegation will be wearing face masks at all times.

✓ All Team members will remain with the delegation at all times during the journey including accommodation at the hotels

✓ A special hygienic corner on each bus- Each bus will contain alcohol gel (sanitizer), face masks and disposable gloves.

✓ All delegations will be placed in separate lodging and dinning areas in order to keep safe social distancing:

A. Meals - The delegations will enjoy their meals in private sections in the main dinning hall.

B. Accommodation - the delegates will be accommodated on dedicated floors exclusively for the delegation.

Important Information:

✓ Travelers must take a PCR test within a maximum of 72 hours prior to the time of departure from a green classified country or region and bring the test results with them to Israel.

✓ Travelers will take a second PCR test at the Ben Gurion International airport and will wait in a designated area at the airport until test results are available. – This protocol is still to be advised.

✓ If the test result is negative and the passenger has not been in contact with an individual who has tested positive inside the aircraft, the passenger will be directed to passport control and will be free to enter the country.

✓ The Ministry of Tourism has opened a special hotline center available 24/7 to provide travelers with directions and vital information while they are in the country. The contact information will be provided to you prior to arrival.



Additional Safety Measures & Info

✓ Our team member will provide daily temperature checks for each member of the delegation and keep a log accordingly.

✓ We use only approved “purple badge*” hotels and services and provide services subject to regulations by the Ministry of Health.

* The Purple Badge - “HaTav HaSagol” in Hebrew – the guidelines established by the Israeli Government and Ministry of Health to maintain the health of tourists, both local and foreign.

✓ Delegations will enjoy small groups of minimum 10 and up to 30 delegates in each bus.

✓ Each member of the delegation will be required to download the Ministry of Health “Shield” app. It is used to monitor those that are sick and alert if anyone was in close proximity to someone who is sick. The app is available in 5 languages: Hebrew, Arabic, English, Russian and Amharic. Our team members will assist you in downloading the app to your phone.


✓ It is mandatory that all delegation members purchase travel insurance prior to their arrival to Israel. The Insurance should specifically cover medical emergency expenses concerning COVID-19 as well as cancellation or changes to your program due to COVID-19.

✓ Upon group departure, there may be a requirement to perform PCR tests at the airport. In such a case, they can perform an expedited test which takes 4 hours and costs 135 NIS (approx \$40). Please take into account that the arrival to the airport will be extended by additional 4 hours in order to do the PCR tests and await the results.

✓ Our company policy requires a \$100 non-refundable and non-transferable deposit at the time of booking in order to secure the reservation. However, until further notice, we will grant the benefit, for new reservations only, full refund in case of cancellation
